The Versus Capital Multi-Manager Real Estate Income Fund ("VCMIX" or the "Fund"), a continuously offered closed-end interval fund, paid a quarterly distribution on its common stock of \$0.295 per share on October 11, 2019, to shareholders of record at the close of business on October 9, 2019. VCMIX intends to make regular quarterly distributions based on the past and projected performance of the Fund. The amount of quarterly distributions may vary, depending on a number of factors.
